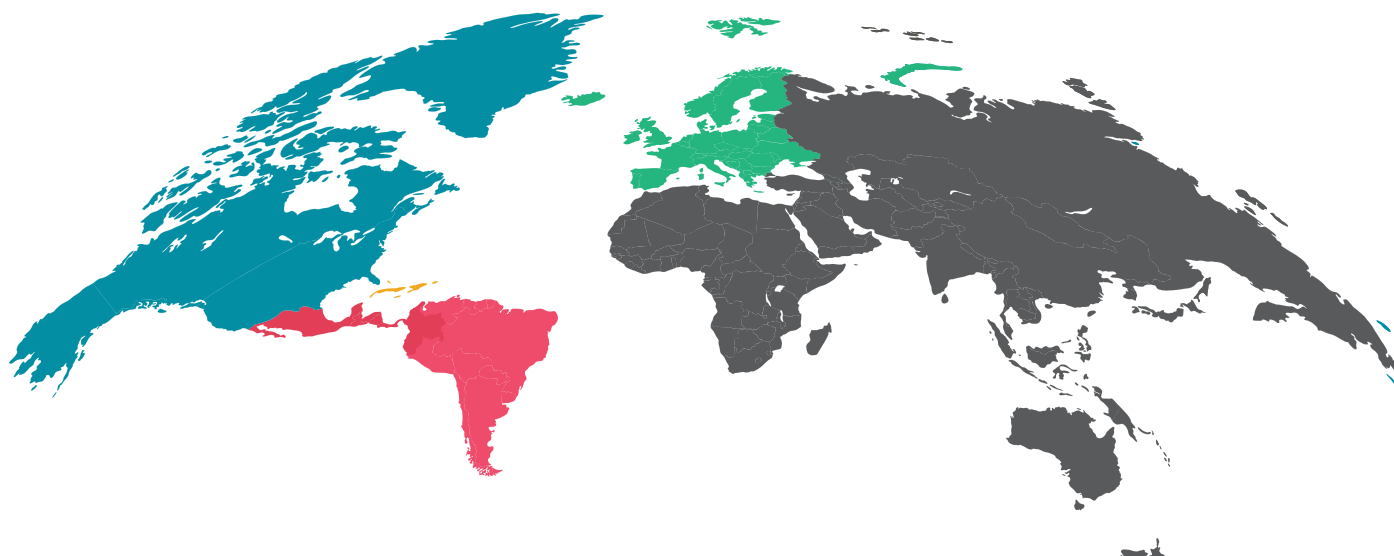
MEMBERSHIP IN THE GLOBAL CIRCLE
