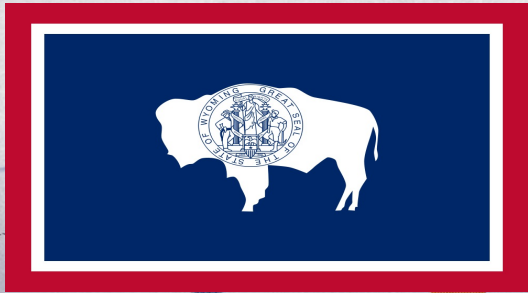

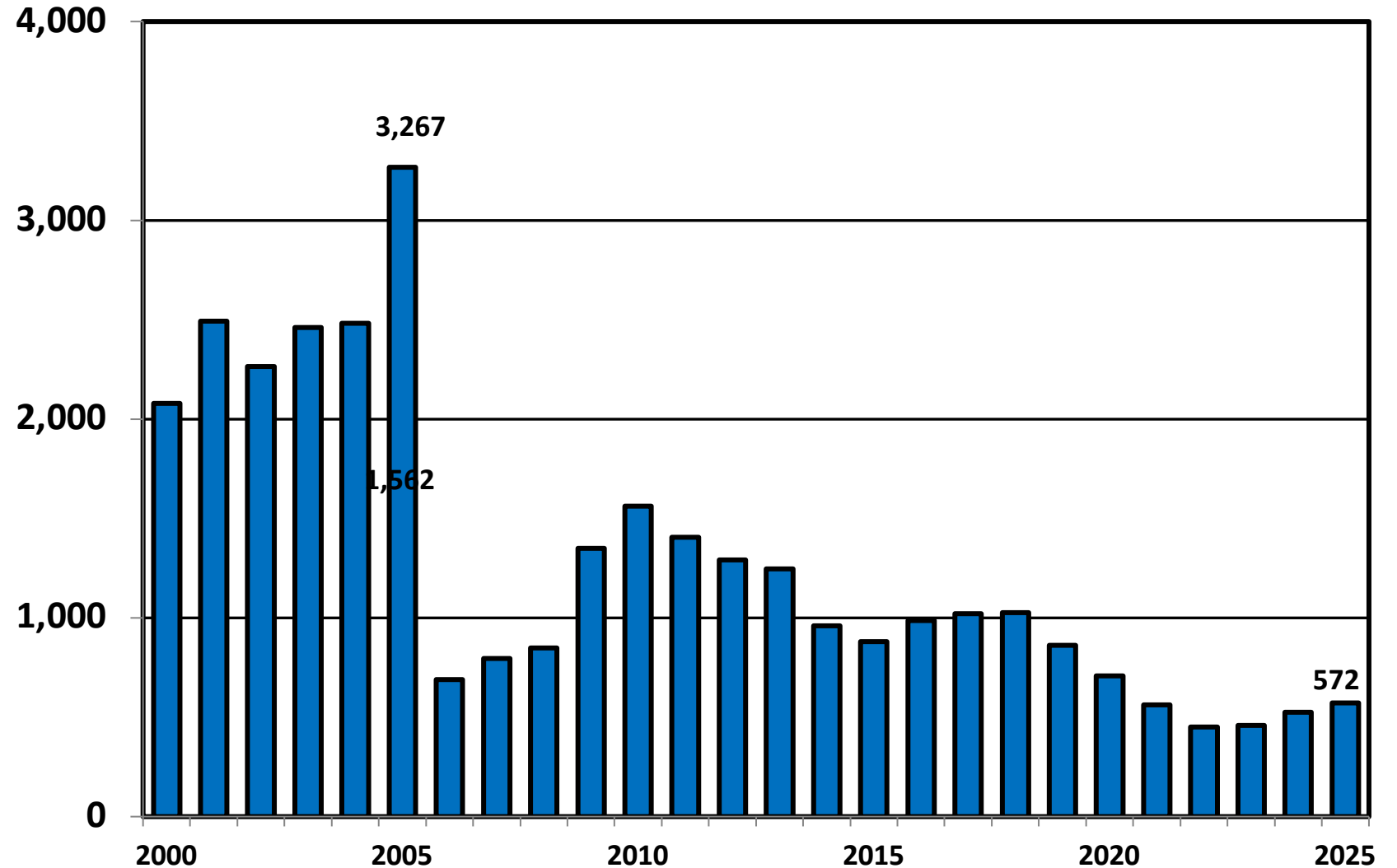

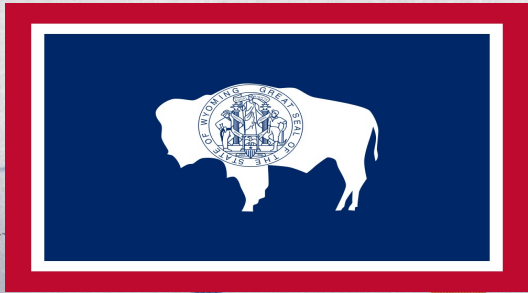

Total Filings Relative to Population 2000 - 2025



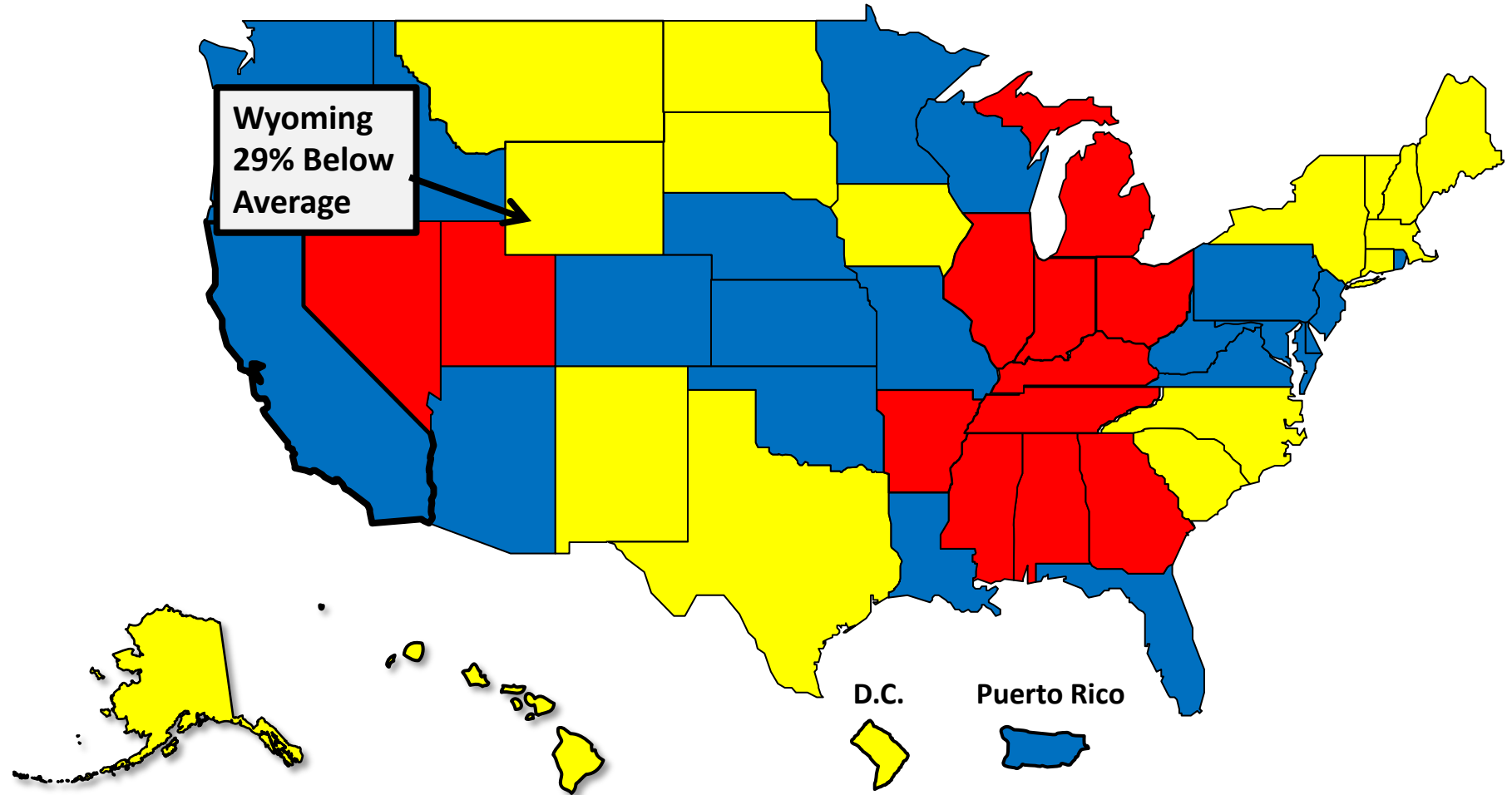

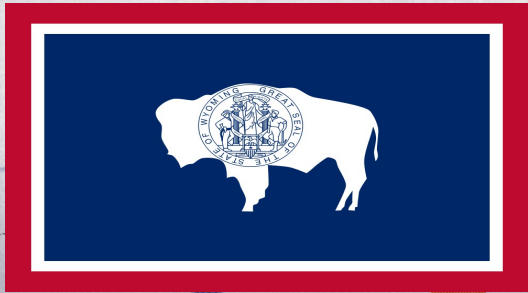
Within 25% of Average

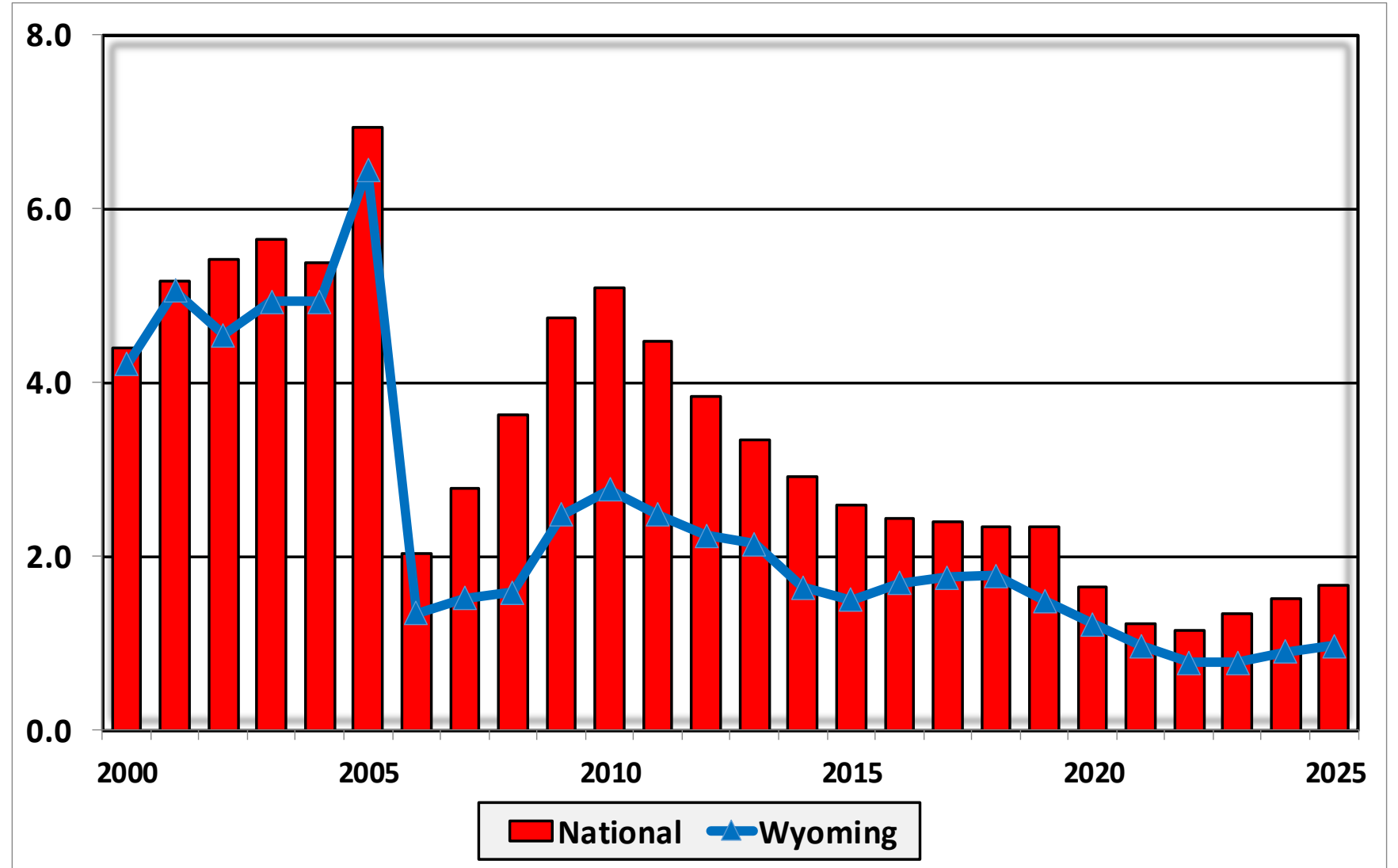

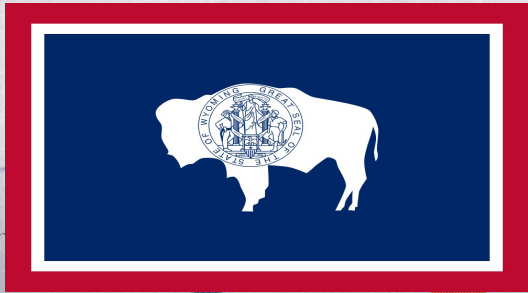

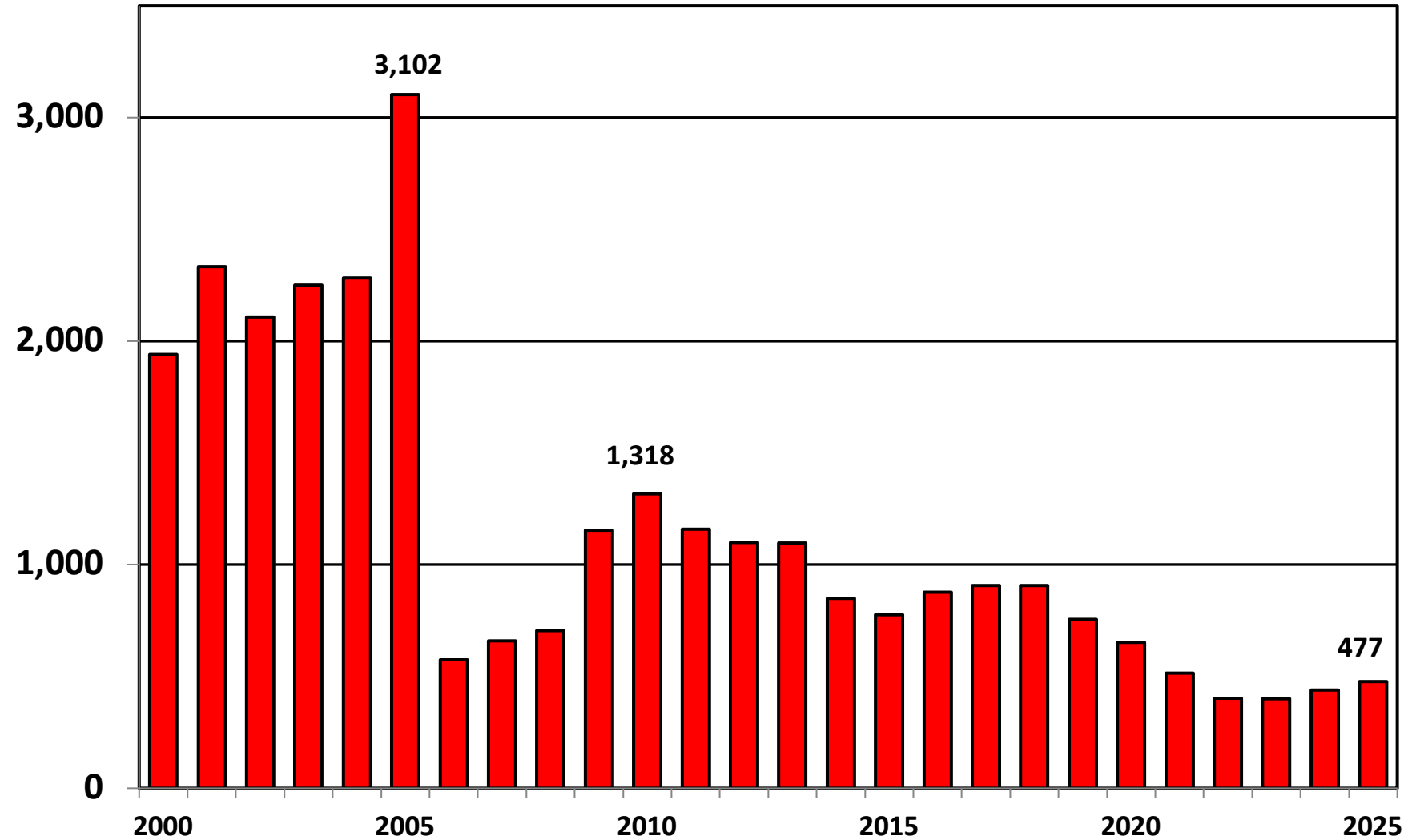

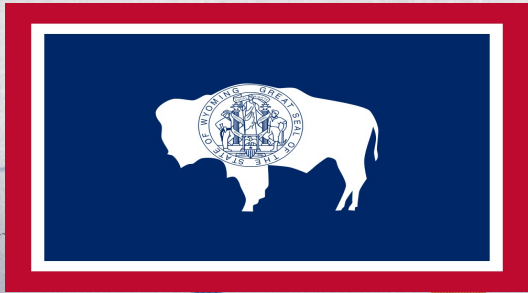

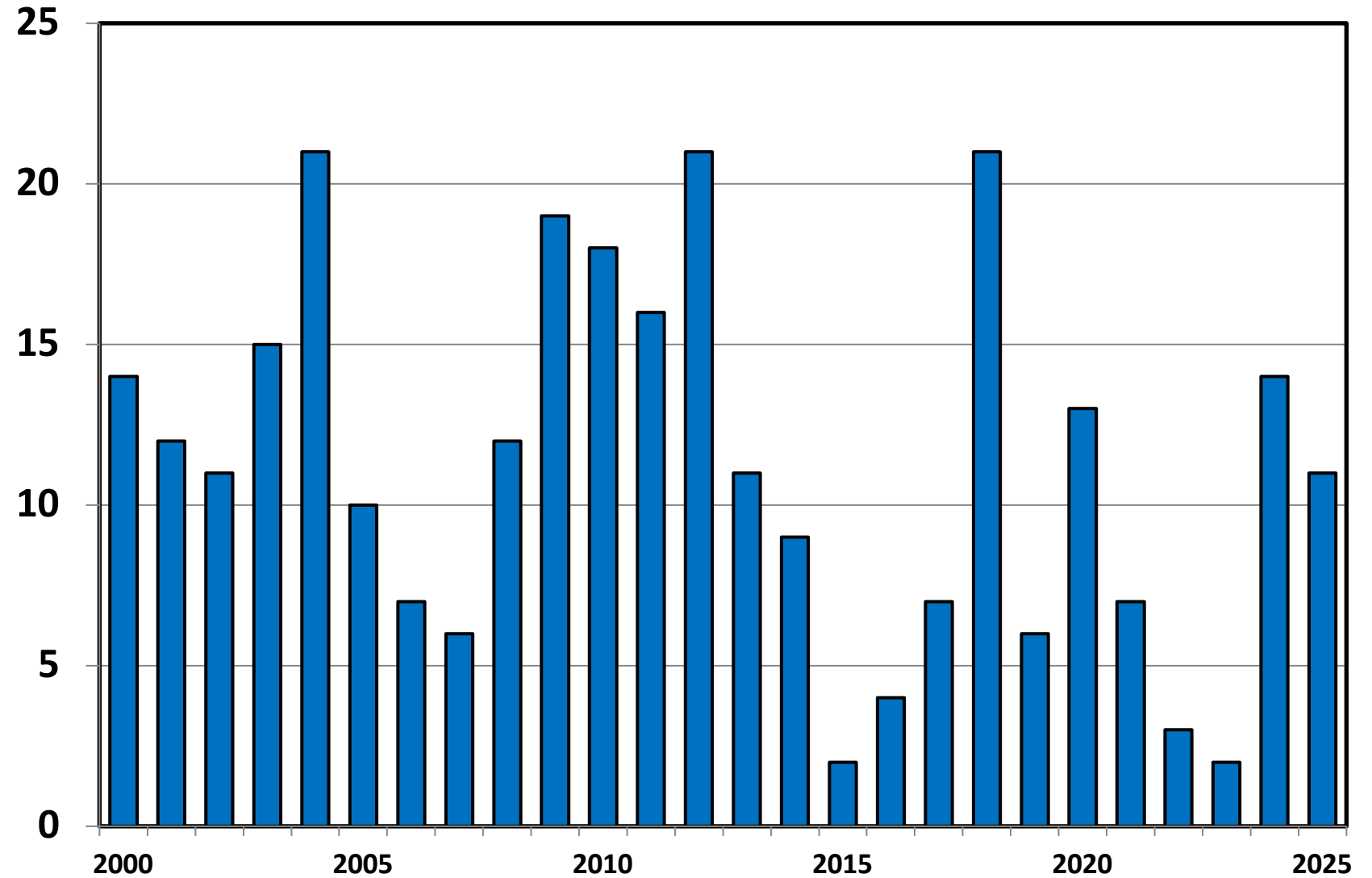

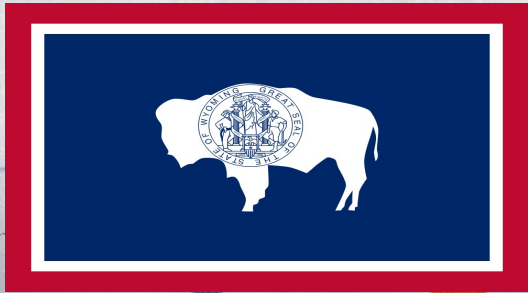

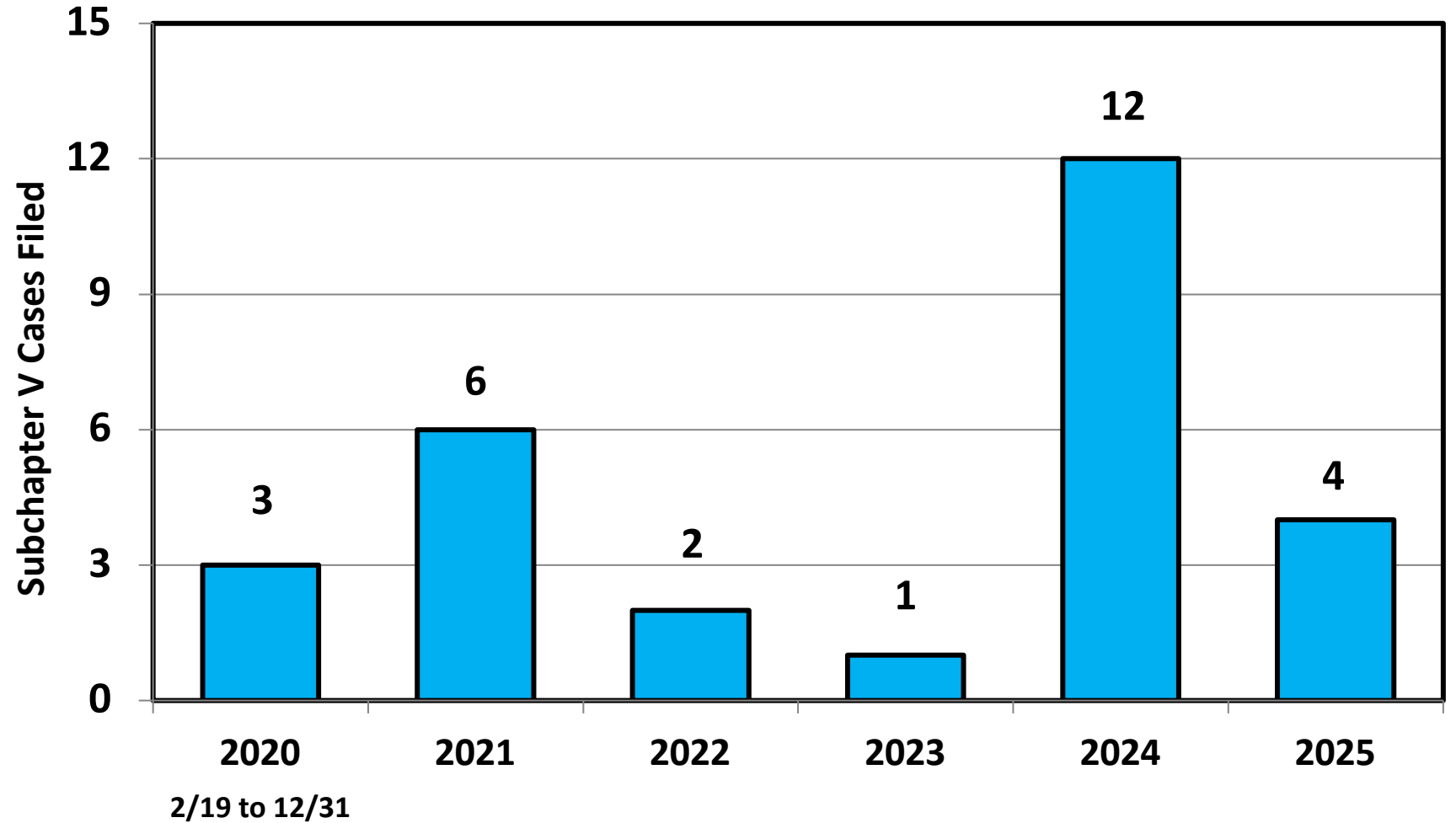

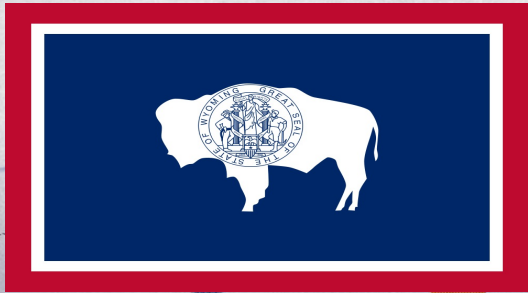

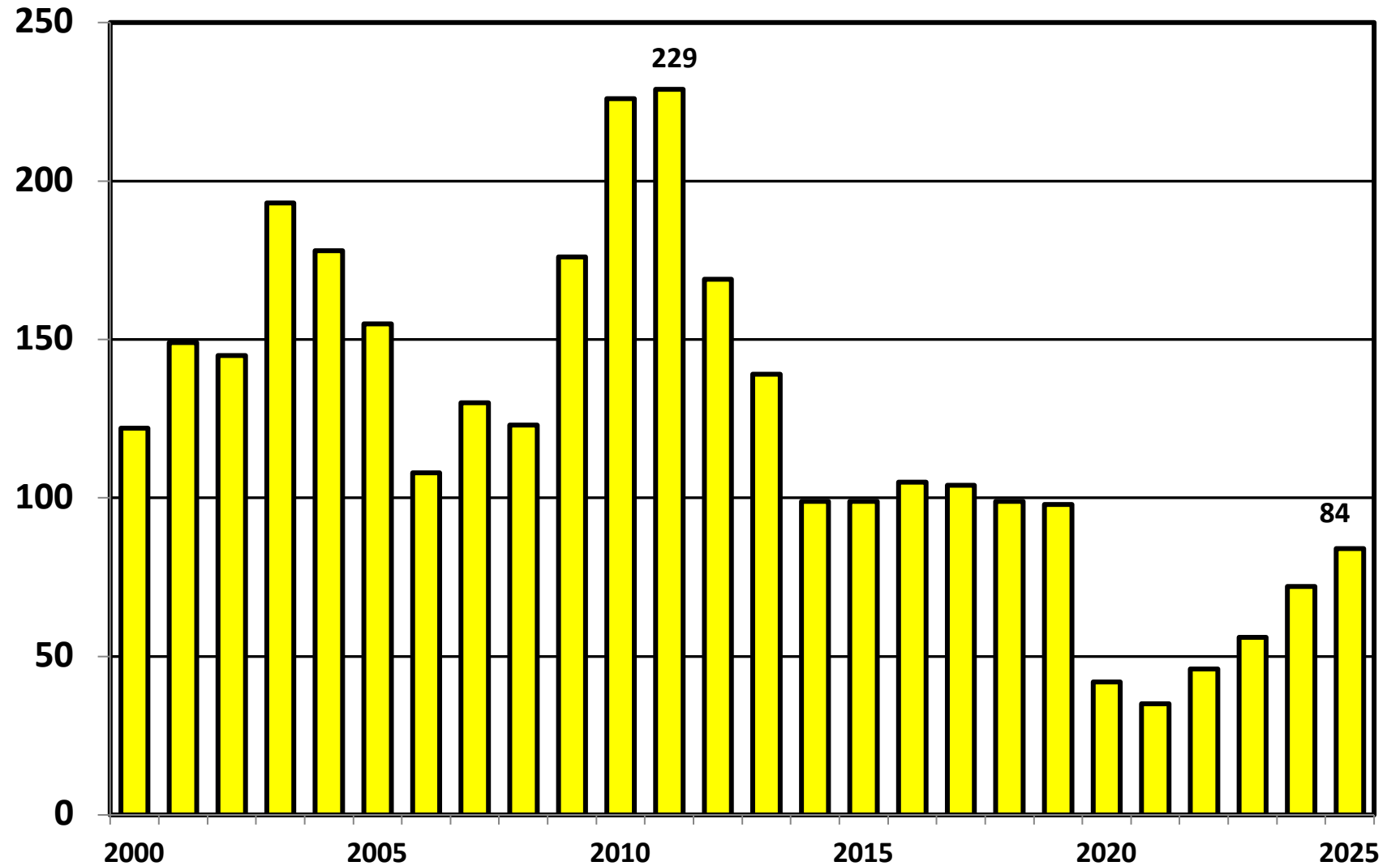

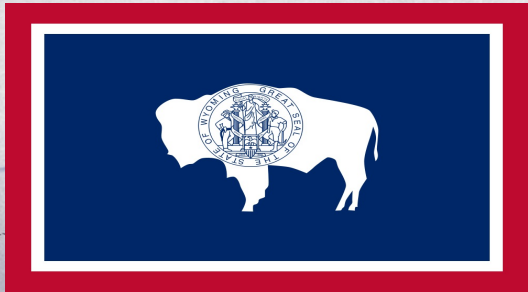

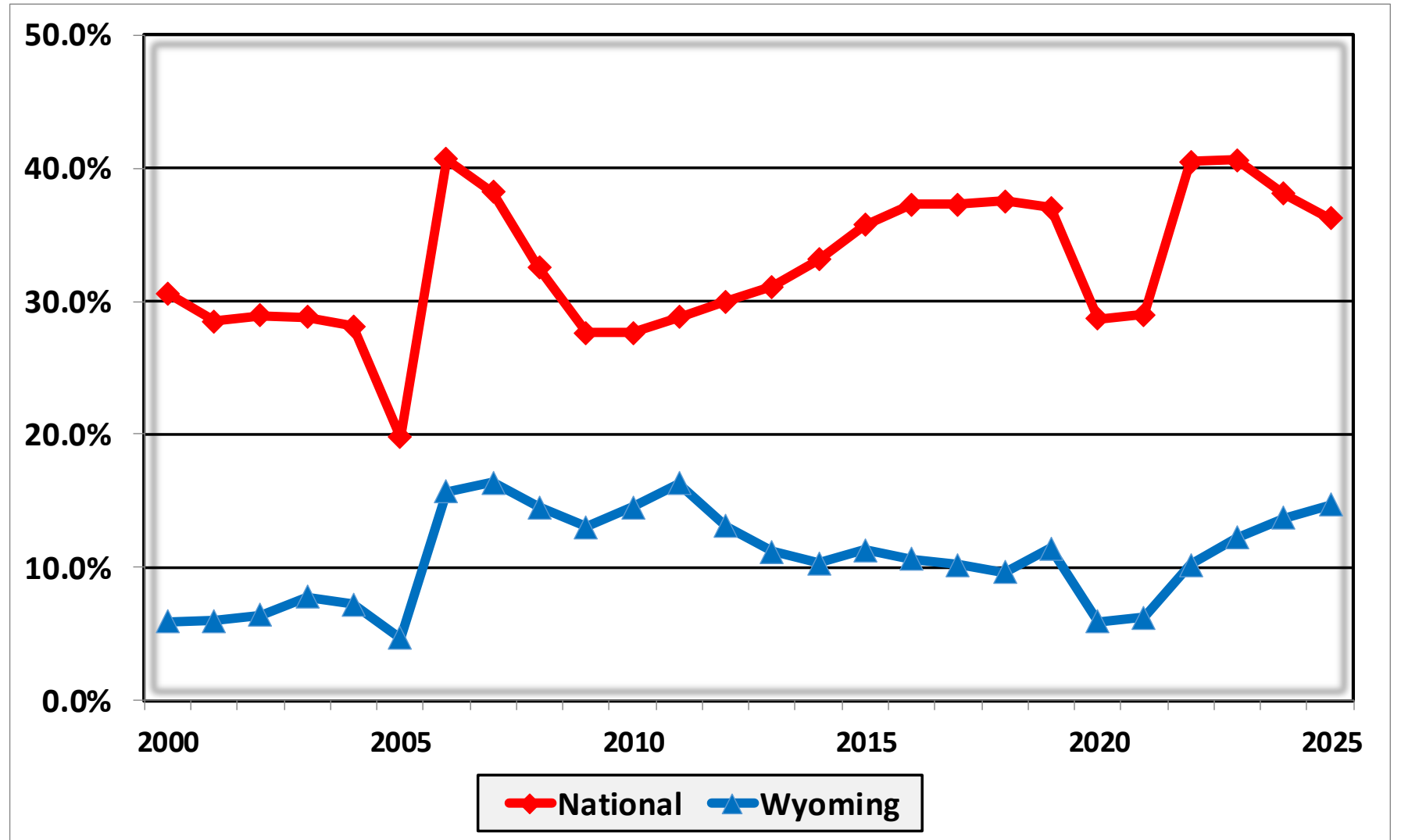

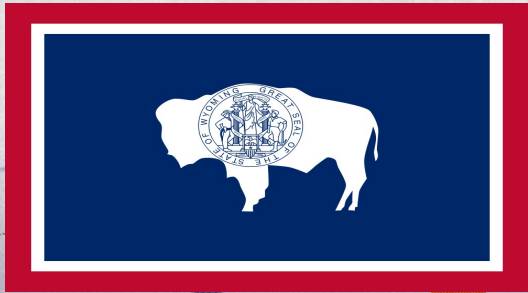

Percent of Cases Filed as Chapter 13 Calendar Years 2000 - 2025



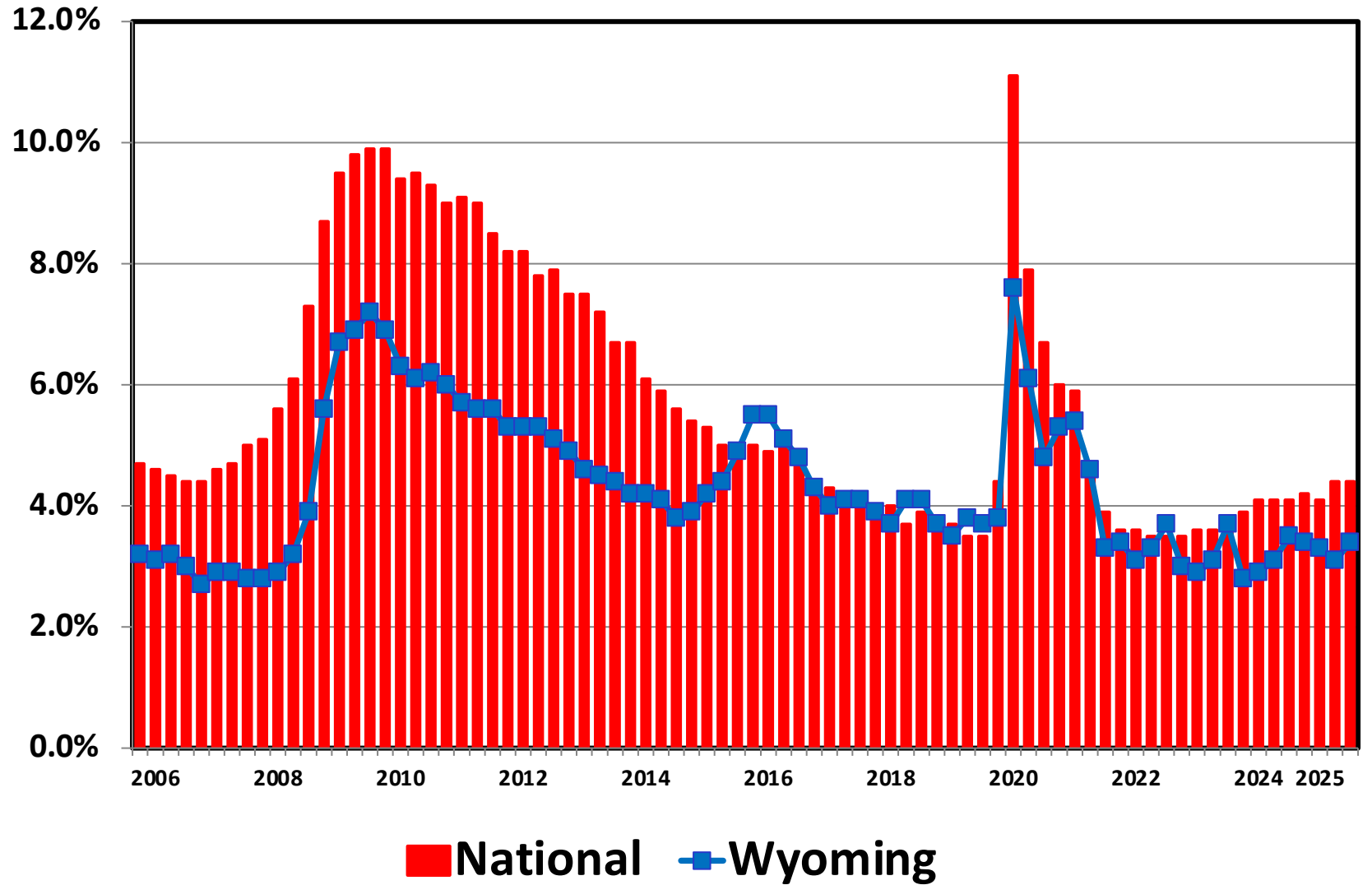

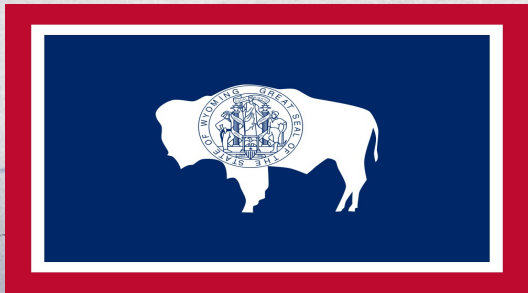


Unemployment Rate By Quarter 2006 - 2025

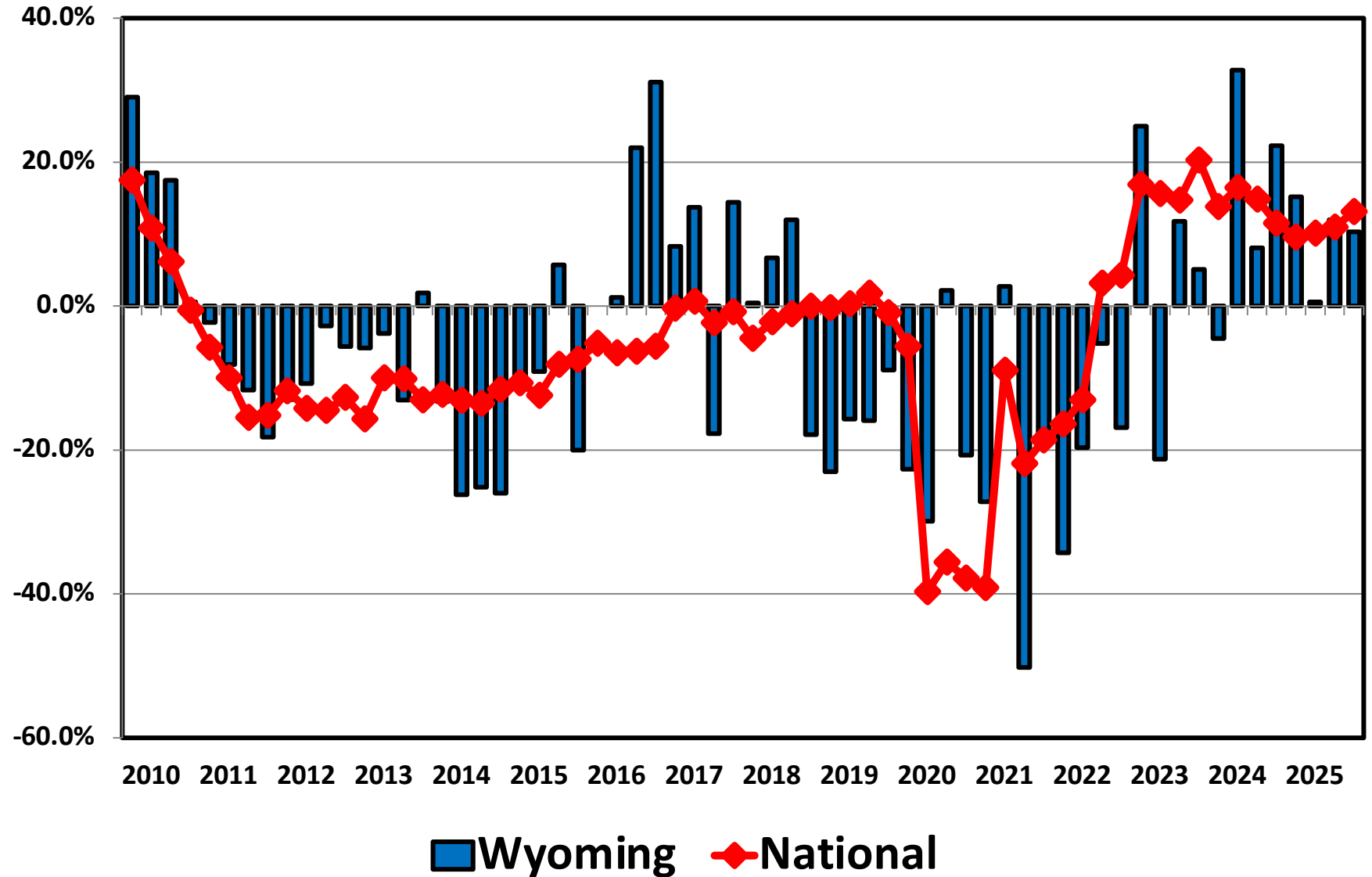

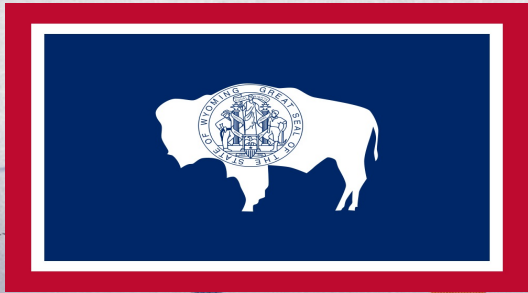

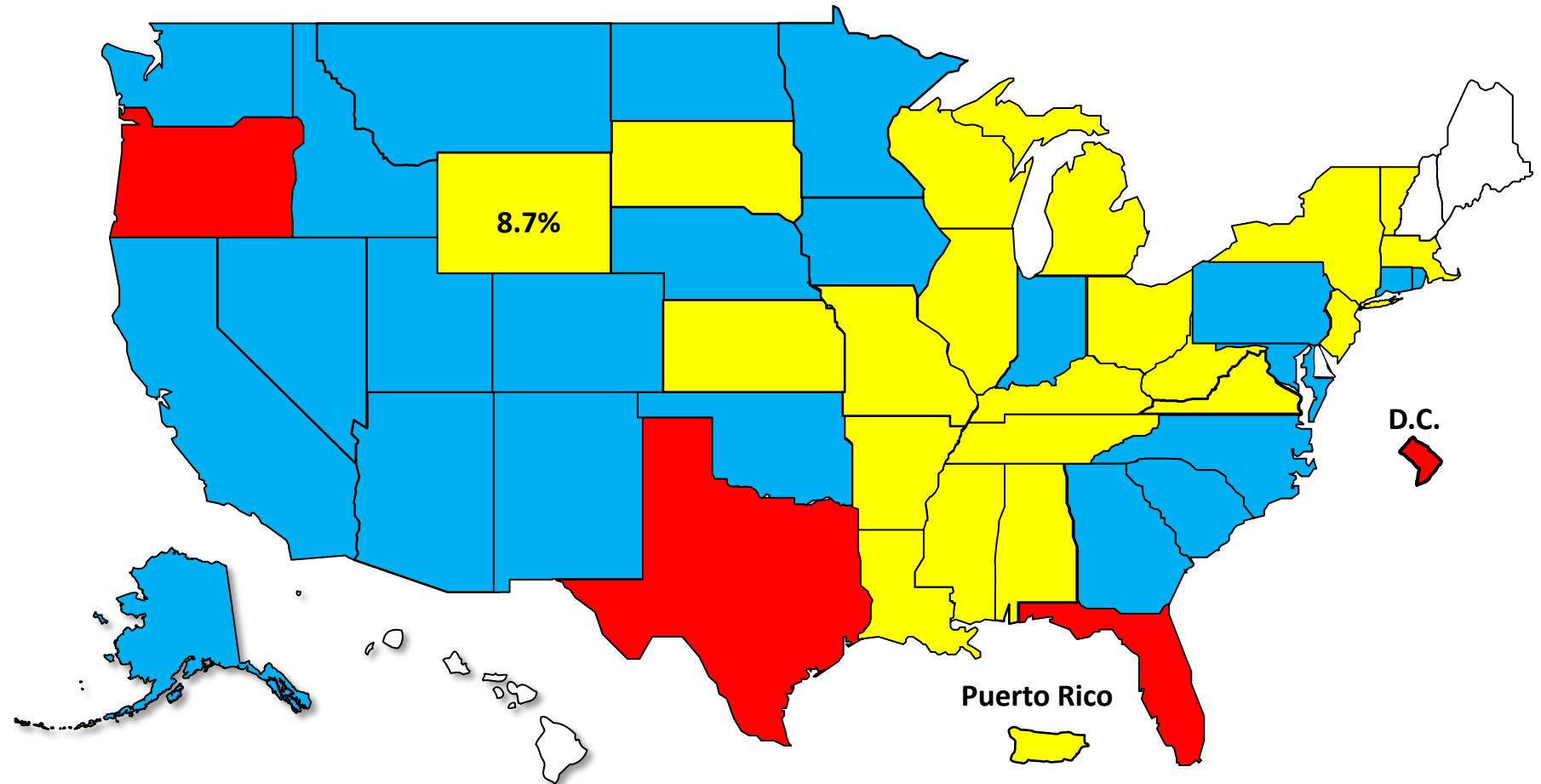

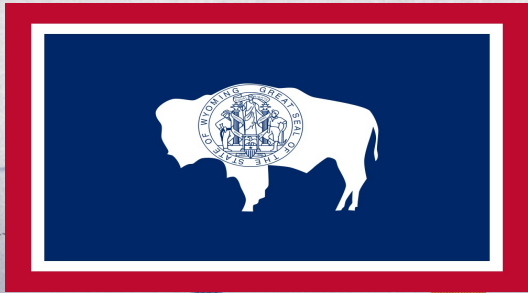

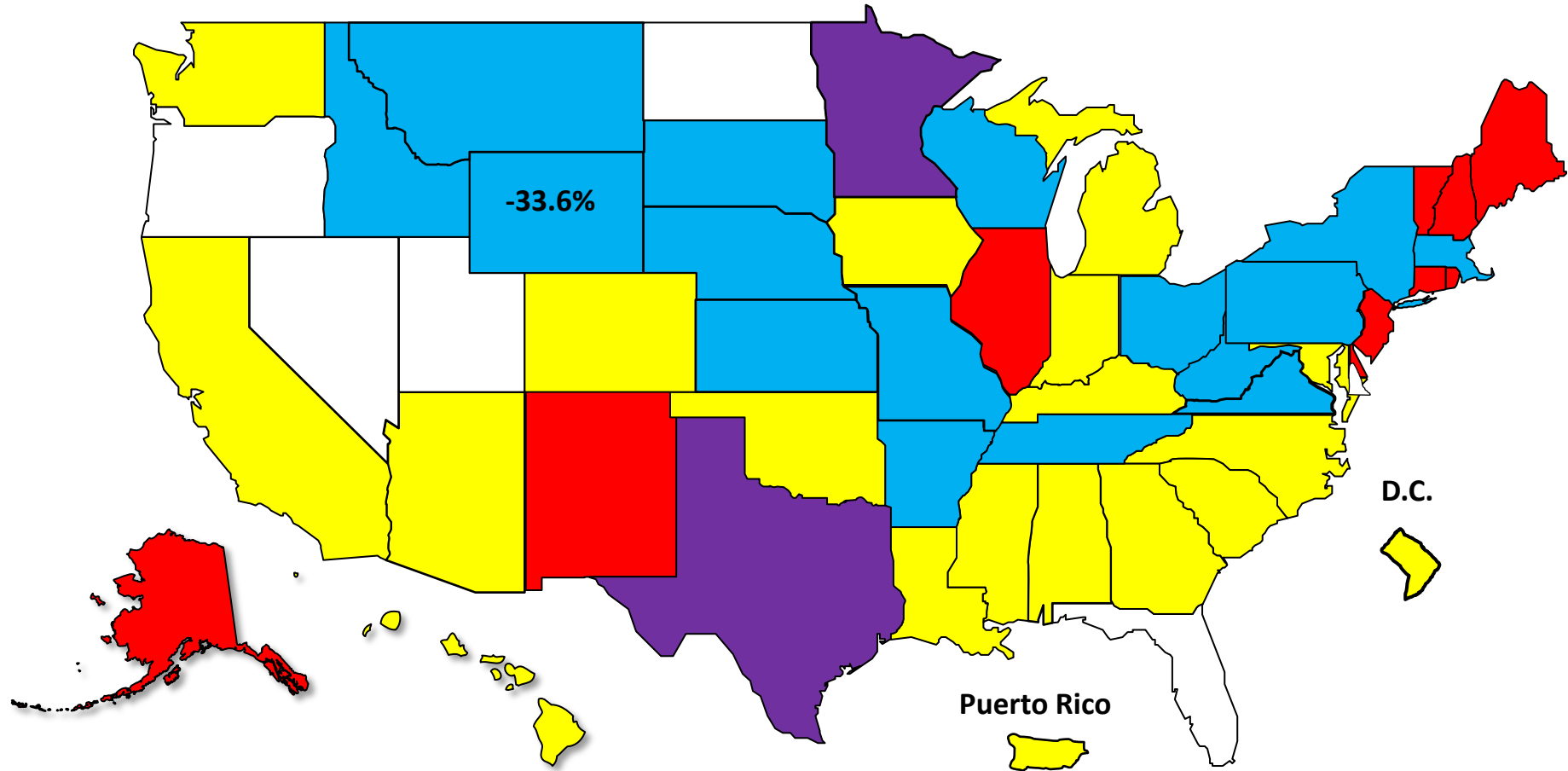
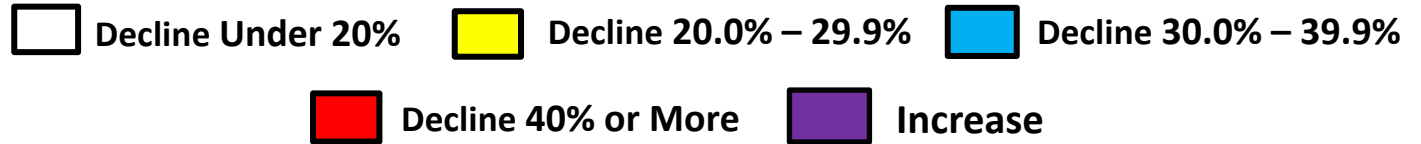

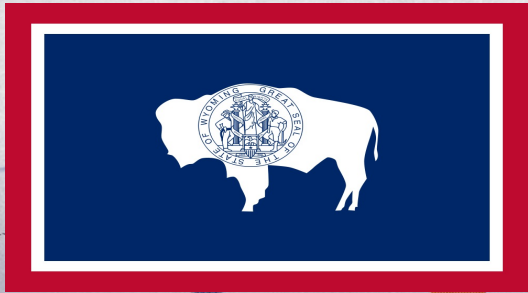

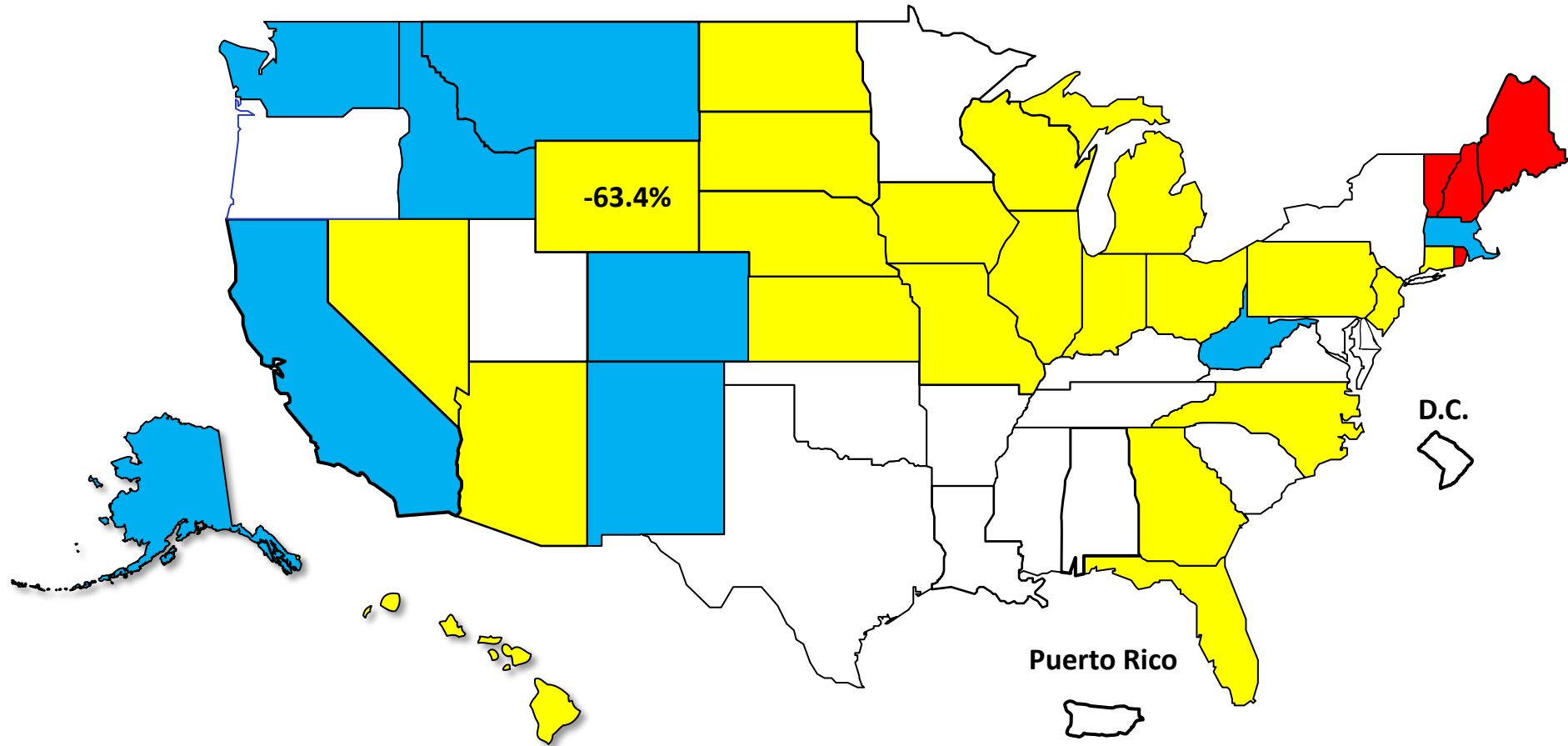
