Bankruptcy filings were fairly light during the week. A portion of the increase over the last three years has been due to the fact that the Martin Luther King, Jr. holiday was celebrated during this week each of the last three years. Historically, filings from Thanksgiving through February tend to be rather low before rebounding in March and April.

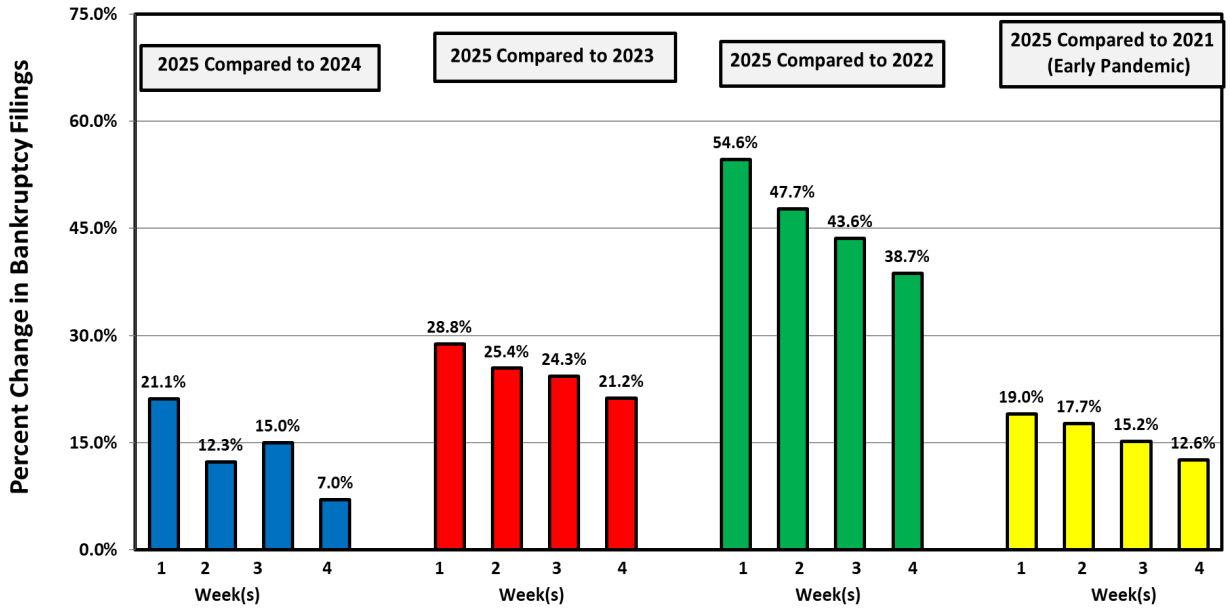

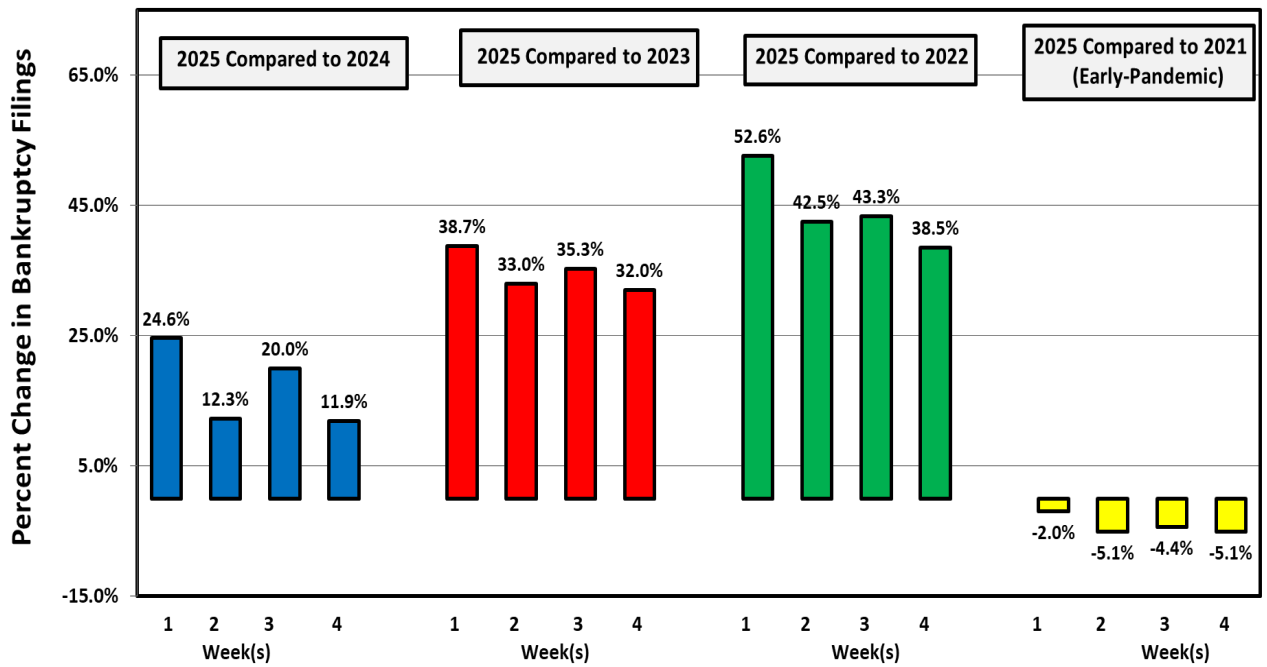

Bankruptcy Filing Trends (All Chapters) Percent Change From 2024, 2023, 2022 and 2021



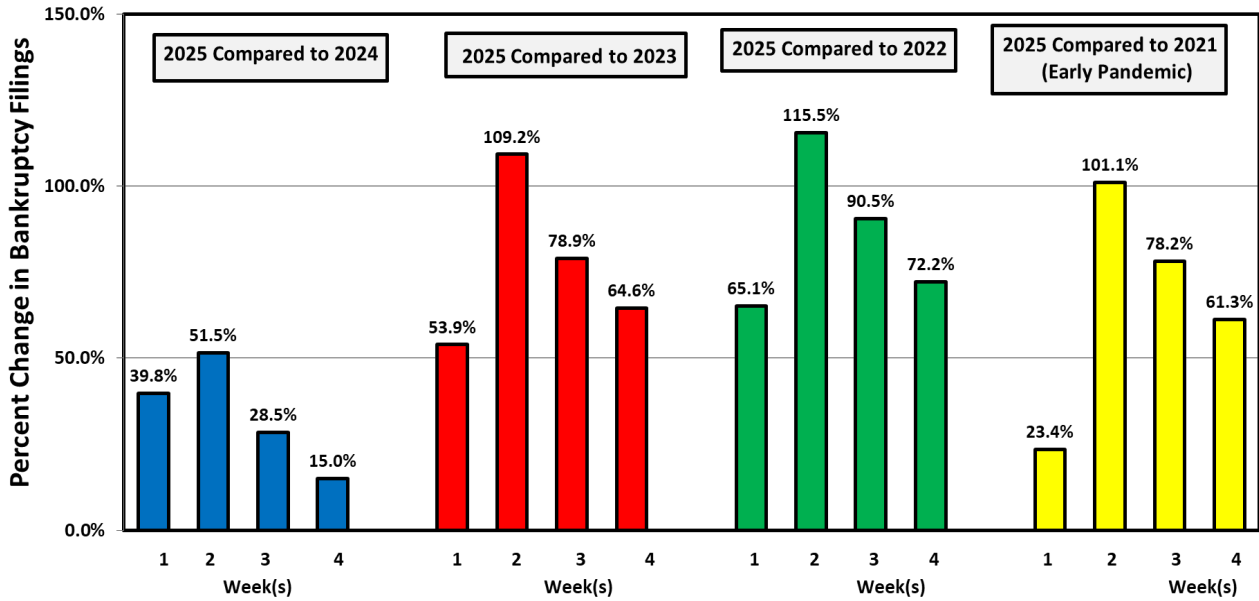

Chapter 7 Filing Trends Percent Change From 2024, 2023, 2022 and 2021



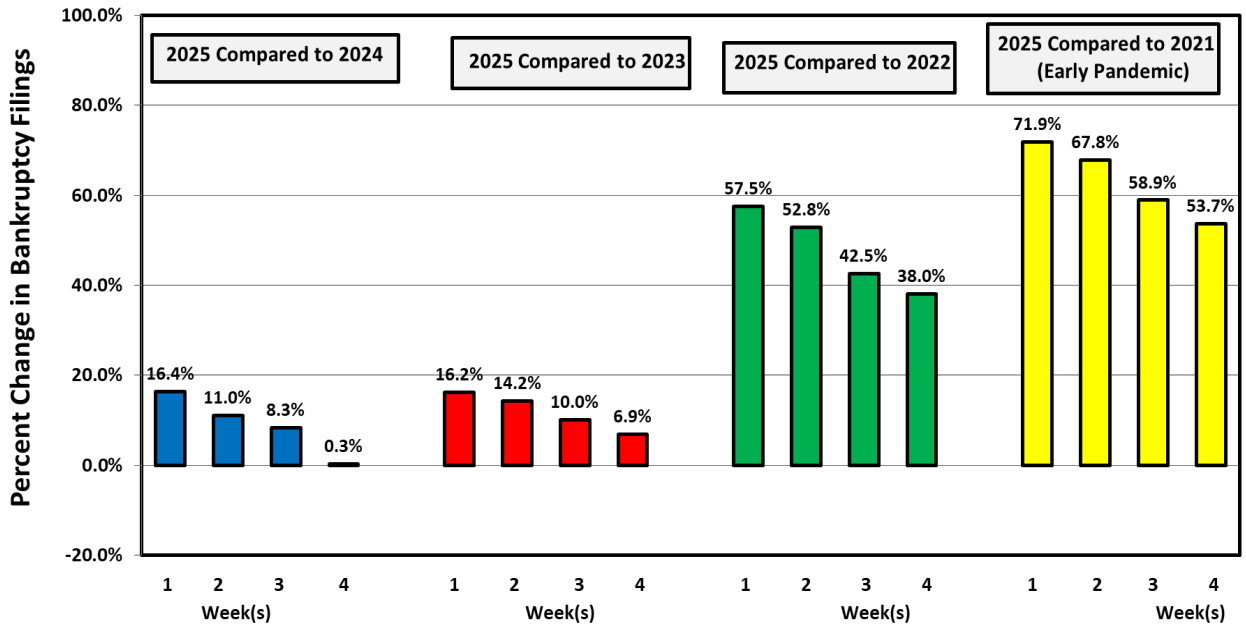

Chapter 11 Cases

Chapter 11 filings were well above the number filed during the same week in prior years. Excluding related filings by corporate subsidiaries, filings were nearly double the volume filed during the same week the last three years.
